	in October 2019. Active planning stopped after February 2020 due to the amount of time needed to consider issues re COVID. However, a new team was formed in January 2021 and meets twice monthly. The team is concentrating on the many details associated with planning such a big project, including funding, existing maintenance issues, and general education involved in establishing a framework for moving forward. No major decisions have been made. This summer there will be opportunities for the congregation to enter the conversation. Rachel Maxwell will be hired to do a Financial Feasibility Study, probably in the fall of 2021. The Board has been working to estimate costs that might be involved, but our sanctuary is so unusual that estimates are difficult. In addition to the summer input sessions, the Team welcomes additional team members. Carol asked if we are keeping up with needed repairs. We reviewed many of those items and noted that they are paid for mostly by endowment funds. Nat asked about input sessions, which will begin in July. Bill Gordon suggested that the Master Plan documents be posted to the website

Pete Asman asked about the payment for capital items - which comes mostly from endowment funds, not from the operating budget.
