
All members, please plan to attend the Annual Congregational Meeting on Sunday June 5, and vote to confirm these members. Below are photos and brief bios.

Leadership Committee:



Bill Gordon – 2-year term

Charles "Rick" Mitts – 1-year term

It is estimated that Cincinnati will be the destination of 500,000 climate refugees.

I am married to Connie. She creates beautiful altar flowers and I do buttons.

We are a team. The first time I saw her she was waiting in line to board the school bus home in elementary school. I was instantly smitten. Love requires commitment. We've been married 54 years, evidence that when I make a love-based commitment, I stick to it; even when it gets hard. I love St. John's.
