The search team will bring proposed selection to the Board and the Board will make the final selection of the Developmental Minister, and negotiate the contract. <p>Search team will begin work this summer to create the St. John's informational packet and have it ready for prospective candidates by November. August 2026 will be the starting date for the new minister and departure date for Rev.
